



## MONTHLY DRAW - TERMS & CONDITIONS

Information on how to participate, Monthly Draw Rules and General Terms and Conditions form part of these Monthly Draw Terms & Conditions. By registering or taking part in this monthly draw, all persons participating herein (the “participants”) agree to be bound by these Monthly Draw Terms and Conditions.

### Monthly Draw Rules

1. The Monthly Draw is open to all individuals
  - (i) aged 13 and above as at the date of review submission (if you are under the age of 13, you should obtain the consent of your parents or legal guardians before participating or submitting any personal information),
